

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding shall be effective as of 2 March 2021 (the "Effective Date") and is between

- (1) **International Baccalaureate Organization**, a Swiss foundation, with a registered address at Route des Morillons 15, 1218 Le Grand-Saconnex, Geneva, Switzerland (the "IB"); and
- (2) **SEKOLAH BUIN BATU**, a school under Yayasan Pendidikan Buin Batu Sumbawa having its registered address at PT. Amman Mineral Nusa Tenggara, Jl. Bung Kamo No. 6 Mataram, NTB 83127 Indonesia (the "School").

The IB and the School are hereinafter collectively referred to as the "Parties" or each individually as a "Party".

RECITALS

(A) The aim of the IB is to develop inquiring, knowledgeable and caring young people who help create a better and more peaceful world through intercultural understanding and respect. To this end the IB works with schools, governments and international organizations to develop challenging programmes of international education and rigorous assessment. These programmes encourage students across the world to become active, compassionate and lifelong learners who understand that other people, with their differences, can also be right.

To achieve these purposes, the IB created and maintains a Primary Years Programme ("PYP"), Middle Years Programme ("MYP"), Diploma Programme ("DP") and Career-related Programme ("CP"), (collectively the "IB Programmes").

(B) The School provides English instruction for children between the ages of 1 – 17 years.

(C) The IB and the School now wish to enter into this Memorandum of Understanding ("MOU"), for the purpose of supporting the education activities and services operated by the School, to provide and deliver the high quality of education that students deserve and parents demand, on the following terms and conditions.

NOW, THEREFORE, the Parties agree as follows:

1. Term

1.1 This MOU shall commence from the Effective Date and shall continue in full force and effect until 31 December 2026. The term of this MOU may be extended for a further period by written agreement by both Parties.

2. The Statement of Acceptance; the School's Responsibilities

2.1 The School shall abide by the terms and conditions of the Rules that shall operate as the agreement between the School and the IB as to their respective rights and obligations. "Rules" means for the purposes of this clause 2 the IB rules, regulations and other requirements that rule the implementation of the IB Programmes, and which may be amended from time to time and are accessible on <https://www.ibo.org/become-an-ib-school/useful-resources/resource-library/> and on the IB's Programme Resource Centre ("PRC").

- 2.2 The School shall pay all applicable IB fees in the assigned currency for the School, which is the [Singapore Dollar (SGD)], as published in the current **PYP Coordinator's Handbook**, and within the published timelines.
- 2.3 The School shall share and bring the *General regulations: Primary Years Programme*, which can be found on the IB public website (<https://www.ibo.org/become-an-ib-school/useful-resources/resource-library/>) to the attention of the School's PYP students and to their parents or legal guardians, so that they understand and accept their respective rights and obligations.
- 2.4 The School shall conduct the cooperation in the field of provision of education by following national standards of education enriched by the standards of other nations having superior education or educational systems valid overseas, having obtained agreement from the minister or appointed official, as set forth in Article 5(b) of the Ministry of Education and Culture, Republic of Indonesia (the "Ministry") Regulation No. 31, 2014 on Cooperation in Educational Management and Provision between Foreign Education Agencies and Education Agencies in Indonesia (the "Act").
- 2.5 The School shall teach students Indonesian language and Indonesian culture, as further set forth in the Act.
- 2.6 The School may add specific components in its curriculum if it is required by the Ministry.
- 2.7 The School shall ensure that its IB Programme teachers meet the IB's professional development requirements.

3. Intellectual Property Rights; Data Protection; and Confidentiality

- 3.1 No exchange of intellectual property rights is implied by this MOU, and nothing in this MOU shall affect either Party's ownership of its intellectual property rights. The intellectual property rights of each Party will remain the intellectual property rights of that Party and neither Party will have the right to use the other Party's intellectual property rights, including trade-marks, logos or names in any promotional materials, without the prior written consent of that Party.
- 3.2 If there is any personal data transferred or exchanged under this MOU, the Parties agree to comply with applicable data protection legislation. The foregoing obligations shall apply during the continuance of this MOU and after its expiry or termination.
- 3.3 Each Party shall treat all confidential information as confidential; disclose it to only to its officers, employees and agents on a need-to-know basis; and shall not disclose it to any third party.
- 3.4 Neither Party shall make any public announcement, advertising, or communication concerning this MOU without the prior written consent of the other Party.

4. Miscellaneous

- 4.1 This MOU constitutes the entire agreement between the Parties with respect to the subject matter hereof and may only be amended or modified in writing.
- 4.2 This MOU does not constitute either Party the agent of the other, or create a partnership, joint venture or similar relationship between the Parties, and no Party shall have the power to obligate or bind the other Party in any manner whatsoever.

4.3 This MOU and the respective rights and obligations of the Parties shall be governed by and construed in accordance with the laws of Switzerland without reference to its conflict-of-laws or similar provisions that would mandate or permit application of the substantive law of any other jurisdiction.

4.4 In the event of a dispute arising out of or relating to any matter under this MOU, the dispute shall be referred to a director of the IB and the School, who will attempt to resolve the dispute within ten (10) business days of such referral date. If such directors are unable to resolve the dispute within such ten (10) business day period, then either Party may immediately seek to have the dispute finally settled in accordance with the provisions of clause 4.5.


4.5 Any dispute, controversy or claim arising out of, or in relation to, this MOU, including the interpretation, validity, breach or termination thereof, shall be finally settled by arbitration by the Geneva Chamber of Commerce in accordance with the Swiss Rules of International Arbitration of the Swiss Chambers' Arbitration Institution (the "Rules") in force on the date when the notice of arbitration is submitted in accordance with such Rules. The number of arbitrators shall be one (1), the seat of the arbitration shall be Geneva and the arbitral proceedings shall be conducted in English. The Parties hereby agree to use information technology systems and electronic communications to the extent permitted in conducting any arbitral proceedings.

4.6 Notwithstanding clause 4.5, the IB may seek injunctive relief with respect to a violation of intellectual property rights or confidentiality obligations in any applicable jurisdiction.


